**DETAILED CONTEST RULES
FOR CITADEL RADIO STATIONS**

1. How to Enter the Contest:

- a. The **Brad Paisley “Welcome To The Future” Video** contest will begin on **Friday 9/18/09** and will end on **Wednesday 9/23/09**.
- b. To participate in the contest, entrants must create a video in which they fill in the blank: “When I grow up, I want to be a _____,” and submit them to Station. Videos can be no longer than 60 seconds or 5 megabytes in size, whichever is less. They can be dropped off at the station at 575 W Roger Road, Tucson, AZ 85705. Entries must be received by Wednesday September 23rd at 11:59am; entries received after this time will be disqualified. All videos must be in either VHS or DVD format. Submissions must include the entrant’s name, address, phone number, e-mail address and date of birth. All videos must be the entrant’s own creation and must not violate or infringe upon any third party rights or property; entries may be disqualified if Station deems, in its sole discretion, any submission to violate any third party right or is otherwise obscene or unlawful. Station is not responsible for lost, stolen, mutilated, destroyed, misdelivered, postage due, illegible, incomplete or untimely entries. Station is not responsible for entries not received due to difficulty accessing the internet, service outages or delays, computer difficulties or other technological glitches. Station is not responsible for any lost, disconnected, dropped, misdirected or incomplete telephone calls. Entrants may be disqualified at the sole discretion of the station. Entrants are responsible for any data charges incurred for transmitting video from their cellphone, if applicable.
- c. One video may be submitted per child. Submitters may enter up to two children.

2. Eligibility Restrictions:

- a. The contest is open to all **KIIM-FM** listeners who are legal United States citizens **11** years of age or younger and who reside in **Pima County, Pinal County or Cochise County, AZ** listening area. Employees of **KIIM-FM**, its licensee, Citadel Broadcasting Corporation, their subsidiaries, affiliated entities, affiliated advertising agencies, participating sponsors/promotional partners, other radio stations in the Tucson area and the members of their immediate families are ineligible to participate

or win. Immediate family shall include spouse, parents, children, siblings, grandparents, grandchildren and any other person residing within the same household. Minors must get their parent or guardian's permission before entering. Tickets will be awarded to the parent or guardian of entrants under the age of 18 who must sign a release in connection with the receipt of the prize.

- b. Listeners are eligible to win a **KIIM-FM** contest only once every thirty days. Only one winner per household is permitted in any contest.
- c. Participants in the contest must possess valid government issued photo identification.
- d. **Winners will be required to sign a contest winner release as a condition of receiving their prize.**
- f. By entering this contest, participants consent to the unrestricted use, publication, editing, broadcast, duplication and distribution by Station, or its representatives, now and in the future, whether for commercial sale or otherwise in any medium whatsoever, of any material submitted in connection with their participation in the Contest. All such material shall become the sole property of Station. Participants acknowledge and understand that Station is and shall be the sole and exclusive owners of the Contest material, including all copyrights and other intellectual property rights, and shall have the right to exploit the Contest performances in any manner and any media whatsoever. Participants hereby assign to Station, its parent, subsidiaries, affiliates, successors and assigns, whatever rights or interest they may now or ever have in the material for any other reason, including but not limited to any rights that they may have to any proceeds arising out of the production, sale or other use of the materials.

3. Prizes:

- a. **The prize is a pair of tickets (2 tickets) to see Brad Paisley at the Cricket Pavilion on Thursday October 1st, 2009. Approximate Retail Value of a pair of tickets: \$150.00 (\$75 per ticket). The video submitted by the winning children will be shown during Brad Paisley's performance of "Welcome To The Future." Prize provided by Arista Nashville.**
- b. All prizes or prize certificates may be picked up at the office of **KIIM-FM, 575 W Roger Road, Tucson AZ 85705**. Any prize or prize certificate not claimed within forty five (45) days of winning will be automatically forfeited by the winner, unless a prize has an expiration date, in which case a prize may be forfeited earlier than forty five days from winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its arrival. **KIIM-FM** is not responsible for the safe arrival of a prize or prize certificate.

- d. Contest prizes are not transferable. Prizes may not be substituted for or redeemed for cash.
- e. Grand Prize winner will receive 1099 IRS Tax form for the value of the grand prize as stated in these contest rules.
- f. Prizes are limited solely to those items explicitly set forth herein and shall not include any and all other expenses, incidentals or taxes that may arise out of the winner's receipt of this prize.
- g. Prizes will be awarded as is, with no written or express warranty.

4. Selection of Winners:

- a. Decisions of station management with respect to the contest are final.
- b. Two winning videos will be randomly selected from among all eligible videos
- c. **Two (2) winners will be chosen and notified on Wednesday September 23, 2009.**
- f. **Winner need not listen/or be present to win. Winners will be notified by telephone on Wednesday September 23, 2009.** If the winner(s) cannot be contacted on **Wednesday September 23, 2009**, they will forfeit their prize and an alternate winner will be selected and contacted.
- g. **The odds of winning depend on the number of eligible entries received.**

5. Conditions:

- a. Photo identification and social security number of the Grand Prize winner may also be required in order to collect the prize. Payment of all federal, state and local taxes are the sole responsibility of the winner. Winners will be required to sign an IRS Form W-9 or the equivalent. Winner will receive a 1099 for the value of the prize as stated in these contest rules.
- b. Winner is required to sign a release in order receive their prize. Failure or refusal to execute the release will result in winner forfeiting the prize. Pursuant to the liability release, the winners will agree to hold **KIIM-FM**, its licensee, Citadel Broadcasting Corporation, their subsidiaries, affiliated companies and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the contest.
- c. By participating in the contest, the winner or winners (and their guest or traveling companion, if applicable) agree to have their name, voice, or likeness used in any

advertising or broadcasting material relating to this contest without additional financial or other compensation, and to sign a publicity release prior to acceptance of the prize.

- d. **KIIM-FM**, in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of the **KIIM-FM** Web Site or who is otherwise in violation of the rules. The station further reserves the right to cancel, terminate or modify the contest if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.
- e. The Station reserves the right in its sole discretion to modify the contest rules and dates at any time for any reason. Material modifications shall be announced on-air, when practical. By participating in this contest, you agree to be bound by these contest rules, any modifications thereof, and by all other rules imposed by Station management. If due to circumstances beyond the control of Station, any event associated with this contest or the prize is delayed, rescheduled, postponed or cancelled, Station reserves the right, but not the obligation, to cancel or modify the contest and shall not be required to award a substitute prize.
- f. No purchase is necessary. The contest is void where prohibited.
- g. Failure to comply with the contest rules may result in a contestant's disqualification, at the sole discretion of **KIIM-FM**.
- h. **KIIM-FM** is not responsible for typographical or other errors in the printing, the offering or the administration of the contest or in the announcement of a prize.
